# Visitors, etc.

**Matt's staff-** Liz has been in contact with Derek from Active Visions, and sees two possible paths for Matt so that he can remain active and not isolated:

#1 Reset expectations of daily staff interactions with Matt to include outside activity of at least 30-45 minutes each day

#2) A "skills refresher" for Matt's staff of what Matt is capable of doing. Matt will say 'no' to any change, but that doesn't mean that he won't do the activity.

She often includes her two boys, Demetri and Devin, who love Matt. She has taken Matt to the beach, cooked and eaten meals with him, and the boys love to play hoops with Matt in the spare bedroom. To let Matt know she is on the way, she emails him a photo.

Funds are available from cash flow to pay Nataiya, currently \$20/hour. Yay!

**Colin-** Colin continues to make intermittent deliveries on Tuesdays with Matt for YIKES! He also goes fishing with Matt. Colin will do a fishing tutorial with Nataiya & Devin, etc in preparation for their trip to Ludington, Michigan.
